You can park in front of the building or in the large area to the west of the building, beyond which is a camping area available to all free of charge Friday and Saturday nights. The park will open at 4:30 pm on Friday evening for early camping setup.

On Saturday from 7:30 to 9:00 AM the vendor entrance on the EAST side of the Museum will be available for unloading. All cars must be off the field by 9:00 AM. A few indoor spaces are available first-come, first-serve. When filled, an outside space will be assigned and fees will be adjusted. This year the 5 music stages are set up among vendor and food areas for the best possible traffic for all.
