The AFF 2014 will be held on Saturday, June 7, 2014 at the Albuquerque Balloon Museum Park from 9:30 AM to 11:00 PM. Following you will find a vendor application and an aerial view of the Museum and grounds.

In the past few years the attendance has spiraled reaching to over 4 thousand music loving people and this year will be no exception. With great performers, free parking, free camping and reasonable entrance fees we expect record attendance.

The Park can be reached from Route I-25 in Albuquerque using the westbound Alameda exit. Travel west .8 of a mile to Balloon Museum Drive. Turn right (north) and continue to Museum entrance in front of the building. You can park in front of the building or in the large area to the west of the building, beyond which is a camping area available to all free of charge Friday and Saturday nights. The park will open at 4:30 pm on Friday evening for early camping setup.

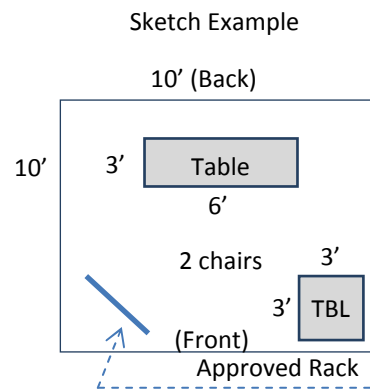
On Saturday from 7:30 to 9:00 AM the vendor entrance on the EAST side of the Museum will be available for unloading. All cars must be off the field by 9:00 AM. A few indoor spaces are available first-come, first-serve. When filled, an outside space will be assigned and fees will be adjusted. This year the 5 music stages are set up among vendor and food areas for the best possible traffic for all.

Please also include a sketch of your space (see example above) and a copy of your sellers permit.

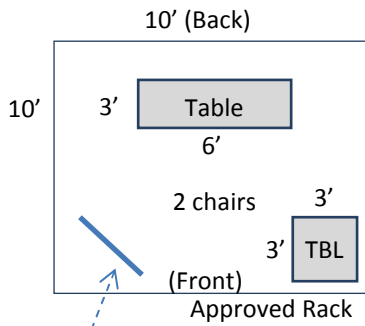
